EXPERIENCE

NOTABLE CASES

- **R. v. Zheng 2010.** Chinese national accused of running a £750,000 cannabis factory was acquitted after 10 day trial at Derby Crown Court.
- **R.v. Newman 2010** Irish Guardsman acquitted of racially aggravated affray at the Central Criminal Court.
- **R. v. Harizaj and Ors 2009.** Multi-handed conspiracy to supply cocaine. This trial lasted for 11 months in the Oxford Crown Court and resulted in all 11 defendants being acquitted.
- **R. v. Hampson and Hampson 2008.** Allegations of rape and cruelty against Mother and Father. Both acquitted of the serious sexual allegations but convicted of cruelty at Reading Crown Court.
- **R v Apps and ors 2008.** Multi-handed violent disorder and GBH. Gang fight in Reading. Acquitted of GBH.
- **R. v. Booker and Ors 2007** Multi-handed Conspiracy to supply cocaine and ecstasy with firearms at the Reading Crown Court.
