Experience

R v S & Others (2007) - Multi-million pound conspiracy to supply cocaine involving 'super grass.'

Operation Charm (2004) - Money laundering. (Prosecution brief - CPS HQ)

In re: Link plc - (2004) Conspiracy to defraud/pervert the course of justice. (Prosecution brief - SFO)

R v M (2004) - Murder of a British Army Recruiting Sergeant by a member of the Irish National Liberation Army [INLA]. (Prosecution brief - CPS HQ)

R v A & others (2002) - Nigerian advance fee fraud. (Defence brief. Prosecuted by SFO)

R v L & others (2002) - Conspiracy to defraud Dean and Chapter of St. Paul's Cathedral of \$100 million. (Prosecution brief - CPS HQ)

In re: L U I plc (2001) - International insurance fraud and laundering of proceeds. Losses in excess of \$50 million. (Brief to advise SFO)

R v B & A (2000) - Advance fee fraud. Defendants extradited from New Zealand. (Prosecution brief - SFO) (In 2004 this case was the subject of a Channel 4 TV documentary)

R v T & others (2000) - Conspiracy to defraud involving the re-introduction of condemned meat to the human food chain. (Defence brief. Prosecuted by West Yorkshire County Council)

R v W & others (1999) - Fraudulent land transfers and fraudulent trading. (Defence brief. Prosecuted by CPS HQ)

R v C & others (1998) - Fraudulent land acquisition and 'long firm' fraud. (Prosecution brief - CPS HQ)

Current Cases

R v & Others - Terrorism - Police operation targeting an alleged network of terrorist recruiter. Defendant charged with both providing and receiving training in the making or use of firearms.
